- Abstract Submission must be done through the Abstract Submission System
- All the Submission must be in English
- Presentation should be an Oral Presentation.
- Each of the presenter is required to make a brief presentation of 15 minutes about his/her research work before the Organizing committee at the event. This session is also be followed by 5 minutes of question-answer session.
- Submission of the supporting materials is necessary
- Copy of passport (1st page as proof of age)
- Copy of abstract submitted as first author
- Completed application form
- Updated Curriculum vitae

#### **Best Poster Award: Cardiology 2020**
