Ayurveda management of emphysema of the lungs

Ayurveda system of medicine has its own importance in the management of respiratory disorders. Chronic bronchial asthma, chronic bronchitis, bronchiectasis and emphysema are considered as chronic respiratory disorders. In emphysema there will be permanent dilation of alveolar sac along with dilation of bronchioles. On physical examination, emphysema patients show cylindrical chest or barrel shaped chest, increased intercostal space, prominent accessory respiratory muscles and resonant note on percussion. In chest x-ray PA view, the radiological findings are increased intercostal space increased translucency of Lung parenchyma, flatter of both hemidiaphragm and vertical heart. In Ayurveda use of disease specific drugs and formulations pathyapathya prayoga, diet therapy, rasayana and ojaskara drugs and pranayama are advised. Drugs include katu tikta rasayukta, ushna, Vatakaphahara, bronchodilator, expectorant, decongestant, mucolytic, immunity booster,

antibacterial, bactericidal, anti-infective and jivaniya drugs. The present paper highlights about the role of Ayurveda in the management of Emphysema of the lungs.

Which could be the risk factors for developing cancer after receiving the covid-19 vaccine?

Introduction: There are several articles in the literature after the covid-19 pandemic showing the necessity of vaccinating people who have a cancer diagnosis to prevent this disease in this group of patients. But what I want to report in this article is that I am facing an increasing number of cases of patients with cancer after receiving covid-19 vaccines and this is what I want to describe in this study, using the thoughts of Hippocrates the father of medicine, that said that “it is more important to consider other ancient medical traditions prior to the knowledge we have nowadays”.

The purpose of this study is to demonstrate that there are cases of patients with cancer diagnosis after receiving three doses of covid-19 vaccination and I will correlate the energy alterations that these patients had that could induce more propensity to have cancer when using this kind of vaccine.

Methods: Two case reports of 40 and 71 years-old female patients with diagnoses of breast and colon cancer respectively months after receiving the third dose of the covid-19 vaccine. Results: What both have in common was energy deficiency inside the five internal massive organs (Liver, Heart, Spleen, Lungs, and Kidney) according to the Five elements theory of traditional Chinese medicine. Conclusion: The conclusion of this study is to show the possibility of having cancer after receiving the covid-19 vaccine because this kind of vaccine has the potential to reduce the vital energy of the patient which is already very low, and leading to a weak state of the immune system and increasing the chance to have, in this case, cancer.
